7. The school will provide well equipped Laboratories, Library and other facilities as per norms of the Board. The relevant books to the academic level of students to be made available in the library and would keep at least 05 books per student subject to a minimum of 1500 books excluding text books.

8. The school will also abide itself by the conditions of affiliation already

prescribed by the State Government concerned.
